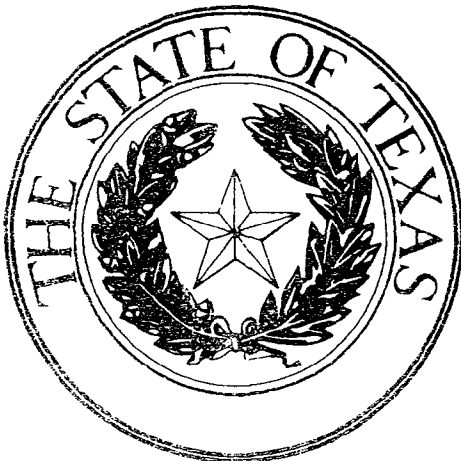

ARTICLES OF CONVERSION

Pursuant to the provisions of Article 5.17 of the Texas Business Corporation Act and Section 2.15 of the Texas Revised Limited Partnership Act, the undersigned converting entity certifies the following Articles of Conversion adopted for the purpose of effecting a conversion in accordance with the provisions of the Texas Business Corporation Act and the Texas Revised Limited Partnership Act.

1. A plan of conversion was approved and adopted in accordance with the provisions of Article 5.03 of the Texas Business Corporation Act providing for the conversion of Tech Spray, Inc. (the "Company"), a corporation incorporated under the Texas Business Corporation Act, to Tech Spray, L.P. (the "Partnership"), a Texas limited partnership.

2. An executed plan of conversion is on file at the principal place of business of the Company at 88 North Hughes Street, Amarillo, Texas 79107, and from and after the conversion, an executed plan of conversion will be on file at the principal place of business of the Partnership at 88 North Hughes Street, Amarillo, Texas 79107.

3. A copy of the plan of conversion will be furnished by the Company (prior to the conversion) or by the Partnership (after the conversion) on written request and without cost to any shareholder or partner of the Company or the Partnership.

4. The approval of the plan of conversion was duly authorized by all action required by the laws under which the Company is incorporated and by its constituent documents. The number of outstanding shares of each class or series of stock of the Company entitled to vote, with other shares or as a class, on the plan of conversion are as follows:

6. The Partnership will be responsible for the payment of all fees and franchise taxes owed to the State of Texas by the Corporation.

8. The conversion will become effective on July 1, 2000, at 12:01 a.m. in accordance with the provisions of Article 10.03 of the Texas Business Corporation Act and Section 2.12 of the Texas Revised Limited Partnership Act.
