**TRADEMARK ASSIGNMENT AND ASSUMPTION AGREEMENT**

THIS ASSIGNMENT AND ASSUMPTION AGREEMENT (this "Assignment") is executed and delivered as of the 20<sup>th</sup> day of April, 2004, by and between BARILOCHE, LLC, a Utah corporation, as assignor ("Assignor"), and BATTERIES & BANDS, INC., a Utah corporation, as assignee ("Assignee").

**RECITALS**

WHEREAS, Assignor has agreed to assign to Assignee the rights related to that certain trademark (Bariloche; Registration No. 2,376,902) ("Trademark").

NOW, THEREFORE, for Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignment of Trademark Rights. Assignor hereby assigns and transfers to Assignee all of Assignor's right, title and interest in, to and under the Trademark free and clear of any and all Encumbrances except for the Encumbrances represented by (a) the obligations arising related to the Trademark, and (b) the matters set forth on Schedule A attached hereto and made a part hereof. In connection with its assignment and transfer of the Trademark, Assignor agrees to indemnify and hold harmless Assignee from any infringement of such Trademark and all other matters arising in connection with the Trademark.

2. Acceptance of Assignment of Trademark Rights. Assignee accepts the assignment of the Trademark, and agrees to assume all the obligations arising related to the Trademark. In connection with its agreement to assume such obligations, Assignee agrees to pay, perform and discharge the obligations as and when any such performance may be due.


3. Counterparts. This Assignment may be executed in multiple counterparts, each of which shall be deemed to be an original but all of which together shall constitute one document.
