Assignor agrees to perform such further acts as may be necessary or desirable to transfer, perfect, and defend the Assignee’s ownership of the such property that are reasonably requested by Assignee from time to time. This Trademark Assignment is expressly made NUNC PRO TUNC, this Trademark Assignment to have the same legal force and effect as if executed on April 29, 2004.

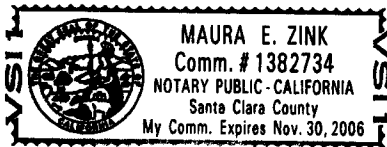
