**ASSIGNMENT OF TRADEMARK RIGHTS**

WHEREAS, PXD SOFTWARE INC. (formerly PXD MUSICSOF, INC.), a Georgia corporation, having its principal place of business at 6690 Roswell Road, Suite 310/358, Atlanta, Georgia 30328 (hereinafter referred to as "ASSIGNOR") is desirous of transferring whatever right, title and interest ASSIGNOR owns in the Trademark Registrations in the United States Patent and Trademark Office, listed on Exhibit A attached hereto, hereinafter referred to as "TRADEMARK RIGHTS".

WHEREAS, FJAY INC., a New York corporation (hereinafter referred to as "ASSIGNEE") is desirous of acquiring the TRADEMARK RIGHTS.

NOW, THEREFORE, for and in consideration of Ten Thousand Dollars (\$10,000) and other good and valuable consideration to ASSIGNOR, the receipt of which is hereby acknowledged, ASSIGNOR has sold, assigned and transferred, and by these presents does sell, transfer and set over unto said ASSIGNEE whatever right, title and interest ASSIGNOR owns in and to the TRADEMARK RIGHTS together with the goodwill of the business symbolized by the TRADEMARK RIGHTS including all reissues, renewals and extensions thereof, for the United States, its territories and possessions and all foreign countries.

ASSIGNOR authorizes the Commissioner of Patents of the United States, and any official of any foreign country or countries, whose duty it is to issue registrations for trademarks or other evidence or forms of industrial property protection, to transfer the Trademark Rights to ASSIGNEE in accordance with the terms of this instrument.
