## NOTICE OF SECURITY INTEREST

WHEREAS, Four D Incorporated, a Minnesota corporation with offices at 3200 West Count Road 42, Burnsville, MN 55337 (hereafter referred to as "Four D"), is the owner trademarks registered by the U.S. Patent and Trademark, or is the owner of applications for trademarks in connection with goods and/or services, as more fully set forth below (hereafter collectively referred to as the "Trademarks and Applications");
