both companies being organized under the laws of France, the merger of said companies under the following name:

La Grange Saint Pierre
71850 CHARNAY LES MACON

was finally approved on January 3, 1994.

Trademark registration MOMMESSIN N° 1,286,324 and the entire interest and goodwill attached to said trademark have therefore been assigned to THORIN SA, newly called MOMMESSIN & THORIN SA, La Grange Saint Pierre — 71850 CHARNAY LES MACON, a company organized under the laws of France.

2. In a General Meeting and a meeting of the Board of Directors dated September 28, 2001, the merger incorporation of MOMMESSIN & THORIN SA — La Grange Saint Pierre — 71850 CHARNAY LES MACON into a new company called MOMMESSIN SA — Le Pont des Samsons — 69430 QUINCIE EN BEAUJOLAIS, a company organized under the laws of France, was finally approved.

This merger-incorporation occurred under the company name of MOMMESSIN SAS, because, upon said merger, MOMMESSIN SA changed its company name to MOMMESSIN SAS.

Consequently, trademark MOMMESSIN N° 1,286,324 and the entire interest and goodwill attached thereto have legitimately been transferred to MOMMESSIN SAS, having its head office at LE PONT DES SAMSONS — 69430 QUINCIE EN BEAUJOLAIS, a company organized under the laws of France.


