(TRADEMARKS)

WHEREAS, Vegetarian Times, Inc., a Virginia corporation (herein referred to as "Owner"), owns trademark registrations and applications pending in the United States Patent and Trademark Office, more particularly described on Schedule A annexed hereto and made a part hereof (the "Trademarks");
