IN WITNESS WHEREOF, the Assignor has caused this assignment to be executed this 19th day of July, 2004.

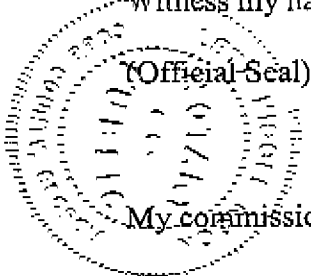
