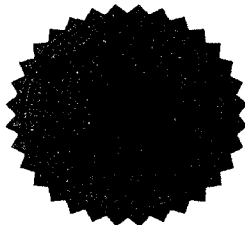

FIRST: That by unanimous written consent of the Board of Directors of the Company dated as of January 14, 1998, a resolution was duly adopted setting forth a proposed amendment of the Certificate of Incorporation of the Company and calling for approval of said proposed amendment by the stockholders of the Company. The resolution setting forth the amendment is as follows:

RESOLVED, that Article 1 of the Certificate of Incorporation of the Company be deleted in its entirety and the following inserted in lieu thereof:

"First: The name of the corporation is RELTEC Communications Inc."

SECOND: That thereafter, pursuant to a resolution of its Board of Directors, the proposed amendment was determined to be advisable and was approved by the stockholders of the Company by written consent dated as of January 14, 1998.

THIRD: That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
