ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Section 607.1006, Florida Statutes, FLOWMATIC SYSTEMS, INC. (the "Corporation") has adopted the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is:
