
Bell Atlantic Network Services, Inc., a corporation organized and existing under the General Corporation Law of the State of Delaware (the "Corporation") does hereby certify that the amendment to the Corporation's Restated Certificate of Incorporation set forth in the following resolution, approved by the Corporation's Board of Directors and Sole Stockholder, was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware:

RESOLVED, that the Restated Certificate of Incorporation of the Corporation be amended by changing Article 1 thereof so that, as amended, the Article shall be and read as follows:

- "1. The name of the Corporation is Verizon Services Corp.
The date of filing its original Certificate of Incorporation
with the Secretary of State was October 14, 1983."
