## CONTRIBUTION AGREEMENT

THIS CONTRIBUTION AGREEMENT (this "Agreement") is effective as of December 26, 2003 (the "Effective Date"), by and among SCN Enterprises, LLC, a Delaware limited liability company ("SCN"), SiTV, Inc., a Delaware corporation (the "Company"), Valdez Productions, Inc., a Colorado corporation ("Valdez") and BVI Investments, Ltd., a Texas limited partnership ("BVI," and together with Valdez, the "Members").

### RECITALS

Other than the "Excluded Assets" and "Excluded Agreements" set forth in Exhibit A attached hereto, SCN desires to contribute to the Company all of its right, title, and interest in and to its assets, whether real, personal, or mixed property, or tangible and intangible property, including its membership interests in SCN Productions and SCN Distribution, as well as any and all office equipment, leases, affiliation agreements and other contracts it is a party to, including specifically all Company Intellectual Property (as defined below) and those assets set forth in Exhibit B attached hereto (such assigned assets are referred to herein as the "SCN Assets") and any and all claims SCN has or may have against third parties relating to the SCN Assets, whether choate or inchoate, known or unknown, contingent or absolute.

(c) each item of Intellectual Property (as defined below) that any SCN Entity uses in connection with its business pursuant to license, sublicense, agreement or permission (“**Licensed Intellectual Property**”).

(d) With respect to the Company Intellectual Property:

(1) The SCN Entities own the Owned Intellectual Property free and clear of all liens, charges, restrictions, claims and encumbrances. The Owned Intellectual Property and the Licensed Intellectual Property constitute all of the Intellectual Property necessary for the current conduct of the SCN Business. To the best knowledge of the SCN Entities and the Members, no SCN Entity has interfered with, infringed upon, misappropriated or otherwise come into conflict with any rights of third parties with respect to the Company Intellectual Property, and no SCN Entity has received any charge, complaint, claim, demand or notice alleging any such interference, infringement, misappropriation or conflict, and to the best knowledge of each SCN Entity, no such claim is threatened by implication because of an offer to


