**TRADEMARK AND TRADE NAME ASSIGNMENT**

This TRADEMARK AND TRADE NAME ASSIGNMENT (this "Assignment"), entered into as of February 2, 2001, is between Stretch Forming Corporation, a California corporation ("Assignor"), and C.R. Laurence Co., Inc., a California corporation ("Assignee"), in connection with that certain Asset Purchase Agreement of even date herewith by and among Assignor and Assignee.

1. Marks. The term "Marks" shall be defined as any and all trademarks, service marks, designs or emblems, now existing or hereafter created, and all registrations and applications for registrations therefor, and all reissues, renewals or extensions thereof
  
2. Assigned Marks. The term "Assigned Marks" shall mean any and all Marks owned or controlled by Assignor and used in connection with the business of manufacturing and distributing automotive sunroofs (the "Business"), which include and/or incorporate in any way the words or phrases "Stretch Forming" and/or "SFC."
  
3. Assignment. Assignor hereby assigns and conveys to Assignee all of Assignor's its right, title and interest in and to the Assigned Marks and all goodwill associated therewith for exclusive use by Assignee in connection with the Business, and Assignee hereby accepts and receives all of Assignor's right, title and interest in and to the Assigned Marks for the Business, including the related goodwill.
  
4. Trade Name. Assignor hereby assigns and conveys to Assignee all of Assignor's right, title and interest in and to the trade names "Stretch Forming" and "SFC" (the "Trade Names") and all goodwill associated therewith for exclusive use by Assignee in connection with the Business, and Assignee hereby accepts and receives all of Assignor's right, title and interest in and to the Trade Names for the Business, including the related goodwill.
  
5. Reservation of Rights. Assignor reserves the right to use the Marks "Stretch Forming" and "SFC" and the Trade Names for its business activities unrelated to the Business that are currently carried on by Assignor.

Nothing contained in this Assignment is intended to or shall add to or enlarge in any respect the representations, warranties, or liability of Assignor made in or undertaken by the Assignor in the Asset Purchase Agreement.
