Assignor requests the Commissioner of Patents and Trademarks to issue the certificates of registration to Assignee.

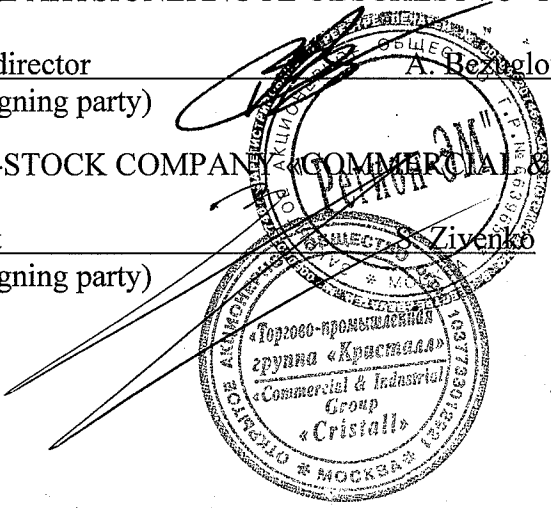
