UNITED STATES TRADEMARK ASSIGNMENT

WHEREAS, HimeyaSoft, Inc. ("HimeyaSoft"), a Japanese corporation with a place of business at 7-5-21 1F Kishi-machi, Saitama-shi, Saitama-Ken 336-0012, Japan, registered the trademark MYSTIC WEAVER in the United States Patent and Trademark Office on November 7, 2000, under Registration No. 2,401,242; and

WHEREAS, HimeyaSoft wishes to assign said trademark and the registration thereof to Little Six, Inc. ("LSI"), the wholly owned arm and instrumentality through which the Shakopee Mdewakanton Sioux (Dakota) Community (the "Community"), a sovereign, federally-recognized Indian tribe, conducts lawful gaming in an exercise of inherent sovereignty and in accordance with the Indian Gaming Regulatory Act, 25 U.S.C. §§ 2701, et. seq., and a corporation organized under the laws of the Community, having its principal place of business at 2400 Mystic Lake Boulevard, Prior Lake, Minnesota 55372;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, HimeyaSoft does hereby transfer, convey and assign to LSI all of its right, title and interest in and to the MYSTIC WEAVER trademark, and the registration thereof, U.S. Registration No. 2,401,242, and the goodwill of the business symbolized by the trademark and the registration thereof, as well as the right to recover for past infringement of the MYSTIC WEAVER mark.
