CONFIRMATION OF TRADEMARK ASSIGNMENT

THIS CONFIRMATION OF TRADEMARK ASSIGNMENT dated as of September 23, 2002 (the "Effective Date") is given by K. Hov A, Inc., a Delaware corporation ("KHOVA"), as "Owner" of the Trademarks, as defined below.

WHEREAS, pursuant to the certain restructuring transactions that occurred on or about October 31, 2001 (the "Transactions"), KHOVA acquired all right, title and interest in and to certain trademarks and trademark applications; and

WHEREAS, adequate documentation setting forth the Transactions is not available at this time;

NOW THEREFORE, for purposes of filing with the United States Patent and Trademark Office, KHOVA hereby confirms as follows:

On October 31, 2001, Washabama LP an Alabama partnership was the owner of the trademarks listed on Exhibit A hereto, together with the goodwill of the business connected with the use thereof and symbolized thereby, the registrations and applications for registration thereof and rights of renewal and extension thereof, all common-law rights related thereto and all causes of action and rights of recovery for past, present and future infringements, dilutions or violations of the foregoing, and the right to bring any proceeding in the United States Patent and Trademark Office or any equivalent agency in any other country for cancellation, opposition or otherwise in connection with the Trademarks (the foregoing, collectively, the "Trademarks").

In connection with the Transactions, Washabama LP's partners made a dividend of their partnership interest in Washabama LP, including the Trademarks, to its parent, Washington Homes, Inc. a Delaware corporation. In connection therewith, Washabama LP assigned, transferred and conveyed to all of its right, title and interest in and to the Trademarks to Washington Homes, Inc., including all of its right, title and interest in and to any and all proceeds, causes of action and rights of recovery for past and future infringement of the Trademarks, as well as all rights of renewal and extension of the Trademarks that are or may be secured in the United States, its territories and possessions and throughout the world, now or hereinafter in effect.

In connection with the Transactions, Washington Homes, Inc. made a dividend of its assets, including the Trademarks, to its parent, Hovnanian Enterprises, Inc., a Delaware corporation. In connection therewith, Washington Homes, Inc. assigned, transferred and conveyed to all of its right, title and interest in and to the Trademarks to Hovnanian Enterprises, Inc., including all of its right, title and interest in and to any and all proceeds, causes of action and rights of recovery for past and future infringement of the Trademarks, as well as all rights of renewal and extension of the Trademarks that are or may be secured in the United States, its territories and possessions and throughout the world, now or hereinafter in effect.

In connection with the Transactions, Hovnanian Enterprises, Inc., made a contribution of certain assets, including the Trademarks, to its wholly owned subsidiary,

KHOVA. In connection therewith, Hovnanian Enterprises, Inc. assigned, transferred and conveyed to all of its right, title and interest in and to the Trademarks to KHOVA, including all of its right, title and interest in and to any and all proceeds, causes of action and rights of recovery for past and future infringement of the Trademarks, as well as all rights of renewal and extension of the Trademarks that are or may be secured in the United States, its territories and possessions and throughout the world, now or hereinafter in effect..


The assignments documented herein are subject to any and all licenses or other rights that may have been granted by any assignor or its predecessors in interest with respect to the Trademarks prior to the Effective Date.

As of the Effective Date, KHOVA is the legal owner of right, title and interest in and to the Trademarks.




