UNDER SECTION 803 OF THE NOT-FOR-PROFIT CORPORATION LAW

We, the Undersigned, being the President and Secretary of the East Coast Coffee Service Association, Ltd. do hereby certify:

(1) The name of the corporation is East Coast Coffee Service Association, Ltd.

(2) The certificate of incorporation of East Coast Coffee Service Association, Ltd. was filed by the Department of State on the 12th day of September 1989. The said corporation was formed under the Not-For-Profit Corporation Law of the State of New York.

(3) The East Coast Coffee Service Association, Ltd. is a corporation as defined in subparagraph (a)(5) of section 102 of the Not-For-Profit Corporation law and is a Type A corporation under section 201 of said law.

(4) Paragraph (1) of the certificate of incorporation of East Coast Coffee Service Association, Ltd. which sets forth the name of the corporation is hereby amended to read as follows:

"(1) The name of the corporation is National Beverage & Products Association, Ltd."

(5) This amendment to the certificate of incorporation of East Coast Coffee Service Association, Ltd. was authorized by the affirmative vote of a majority of the members entitled to vote thereon at a meeting of the members duly called and held on the 8th day of August, 1995, the affirmative vote being at least equal to the quorum; and the consent of a majority of the members of the entire Board of Directors of the corporation voting in person at a meeting duly called and held for that purpose on the 13th day of June, 1995.

(6) The Secretary of State of the State of New York is hereby designated the agent of the corporation upon whom process against it may be served. The post office address to which the Secretary of State shall mail a copy of any process against the corporation served upon him as agent of the corporation is c/o Robert A. Roseman, Esq., 39 Broadway, Suite 2704, New York, New York 10006.


