
**TRADEMARK ASSIGNMENT AGREEMENT**

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") effective as of October 30, 2004, is between Staveley Instruments, Inc., a Delaware corporation located at 421 North Quay Street, Kennewick, Washington 99336 ("Assignor") and Staveley, Inc., a Delaware corporation located at 192 International Boulevard, Glendale Heights, Illinois 60139 ("Assignee").

- A. Assignor has adopted the trademark STAVELEY INSTRUMENTS for eddy current and ultrasonic non-destructive testing equipment and modules in Class 9, and is also the owner of certain common law rights in and to the mark STAVELEY (together, the "Marks").
- B. Assignor owns U.S. trademark registration number 1,835,203 for the Mark (the "Registration").
- C. Assignor wishes to assign and Assignee wishes to obtain all right, title and interest in the Marks and the Registration, together with the goodwill symbolized by the Marks.

In consideration of the foregoing and for other good and valuable consideration, receipt of which is hereby acknowledged, Assignor assigns to Assignee all its right, title and interest in and to the Marks and the Registration, together with the goodwill of the business in connection with which such marks are and were used.
