RELEASE OF TRADEMARK SECURITY AGREEMENT

RELEASE, dated NOVEMBER 3, 2004, with an effective date of AUGUST 13, 1999, granted by CITICORP NORTH AMERICA, INC. ("CITICORP").

WITNESSETH:

WHEREAS, YOUNG'S MARKET COMPANY, a Delaware corporation, ("YOUNG'S") and CITICORP entered into a Trademark Security Agreement, dated as of JANUARY 31, 1990, pursuant to which YOUNG'S granted to CITICORP as security interest in all of the trademarks (as such terms are defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security was recorded with the United States Patent and Trademark Office on February 2, 1990 at Reel 0688 Frame 0616 with respect to the United States trademark registrations listed on Schedule A attached hereto and forming a part hereof;

WHEREAS, YOUNG'S has requested that CITICORP release its liens upon the Scheduled Trademarks; and

WHEREAS, CITICORP is willing to release such liens;

NOW, THEREFORE, CITICORP hereby releases its entire right and interest in the Scheduled Trademarks created by the Trademark Security Agreement and said Trademark Security Agreement and the lien and security interest granted thereby to CITICORP shall hereupon cease and terminate.
