

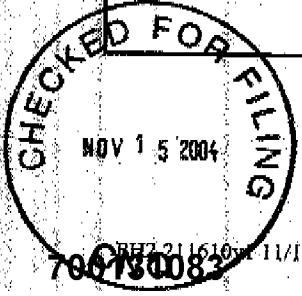

ASSIGNMENT OF TRADEMARK

WHEREAS, Pierre L. Mombinie, an individual, residing at 3208 Bruce Drive, Fremont, CA 94539, referred to herein as "ASSIGNOR", is the owner of the trademark "BLACK HOLE" (the "Mark") which is the subject matter of U.S. Trademark Registration 1,863,114 registered November 15, 1994;

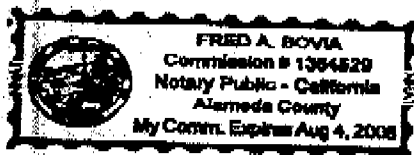
