

WHEREAS, Assignor has used and is the owner of the trademark TURNBURY in connection with apparel (hereinafter referred to as the "Assigned Trademark"); and

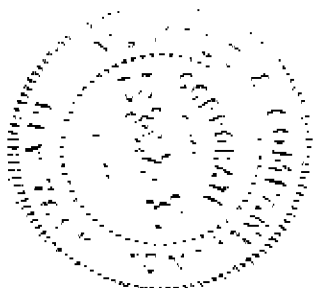
