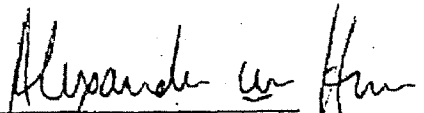
3. The name of the Delaware limited liability company into which the Company shall be converted as set forth in its certificate of formation is G. D. Searle LLC.

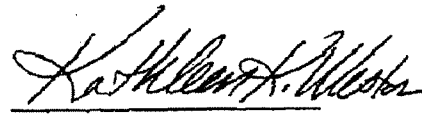
4. The conversion of the Company to a Delaware limited liability company has been approved in accordance with the provisions of Section 228 and Section 266 of the GCL.
