**CONFIRMATORY RELEASE AND DISCHARGE
OF SECURITY INTEREST
(UNITED STATES)**

WHEREAS, pursuant to a Trade-mark Security Agreement between Canadian Imperial Bank of Commerce ("CIBC") and CNC Global Inc. made as of November 12, 1998 (the "Agreement") and placed on file in the United States Patent and Trademark Office ("USPTO") under Reel/Frame No. 1844/0846 on or about January 14, 1999, a security interest was granted in favour of CIBC in and to the trade-marks and registrations therefore set out in "Schedule A" (the "Trade-marks");

AND WHEREAS CNC Global Inc. assigned all of its right, title and interest and in and to the Trade-marks and the goodwill associated therewith to CNC Global Limited ("CNC") on or about September 20, 2002, such assignment was recorded with the USPTO on October 3, 2002 under Reel/Frame No. 2594/0381;

AND WHEREAS CIBC has released all of its interest in and to the Trade-marks pursuant to a Termination and Release made as of June 30, 2004 and wishes to confirm the release by having this Confirmatory Release and Discharge of Security Interest recorded in the USPTO;

NOW THEREFORE, in consideration of the foregoing, and other good and valuable consideration, the receipt and adequacy of which are acknowledged, CIBC:

1. confirms that it has not assigned or otherwise disposed of its interest in and to the Trade-marks; and
2. has released and discharged and does hereby release and discharge the full interest granted to CIBC in and to the Trade-marks.
