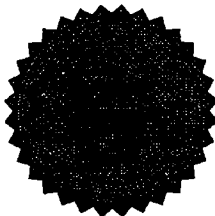

The undersigned President and Secretary of Stratcor Performance Materials, Inc., a Delaware corporation, and the undersigned President and Secretary of U. S. Vanadium Corporation, a Delaware corporation, **DO EACH HEREBY CERTIFY:**

**FIRST:** That the name, date and state of incorporation of the constituent corporations of the merger are as follows:

<u>Name</u>	<u>State and Date of Incorporation</u>
Stratcor Performance Materials, Inc.	Delaware, August 15, 2002
U. S. Vanadium Corporation	Delaware, March 5, 1986

**SECOND:** That the name of U. S. Vanadium Corporation, the surviving corporation of the merger, is to be changed to Stratcor, Inc., a Delaware corporation. Otherwise, the existing Certificate of Incorporation of U. S. Vanadium Corporation, the surviving

corporation, now to be known as Stratcor, Inc., shall continue to be the Certificate of Incorporation of the surviving corporation.

**THIRD:** That the Boards of Directors of U. S. Vanadium Corporation, and Stratcor Performance Materials, Inc., by written consents dated June 22, 2004, adopted a plan to merge Stratcor Performance Materials, Inc. into U. S. Vanadium Corporation, and to change the name of U.S. Vanadium Corporation to Stratcor, Inc. and adopted the following resolutions:

**RESOLVED**, that Stratcor Performance Materials, Inc. be merged into U. S. Vanadium Corporation, that U. S. Vanadium Corporation assume all of the obligations of Stratcor Performance Materials, Inc., that the name of U. S. Vanadium Corporation be changed to Stratcor, Inc., that the outstanding 100 shares of Common Stock, without par value, of Stratcor Performance Materials, Inc. be cancelled, and that the merger, change of name and cancellation of shares be effective July 1, 2004.

**RESOLVED**, that the Vice President and the Secretary of each of the constituent corporations be and hereby are authorized and directed to make and execute a Certificate of Ownership and Merger and to file such Certificate in the office of the Secretary of State of Delaware.

**FOURTH:** That the parent (sole stockholder) of each of the constituent corporations, Strategic Minerals Corporation, a Connecticut corporation, approved the merger and name change by written consent dated June 22, 2004.
