TO THE AMENDED AND RESTATED
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 14-2-1002 of the Georgia Business Corporation Code (the "Code"), the undersigned corporation adopts the following Amendment to its Amended Articles of Incorporation:

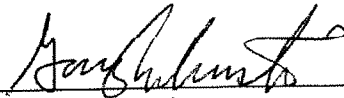
1. The name of the corporation is CLEARWAVE Corporation.

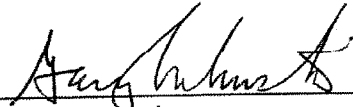
