

**FIRST AMENDMENT TO AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT**

THIS FIRST AMENDMENT, dated as of December 1, 2004, to the Amended and Restated Trademark Security Agreement, dated as of May 28, 2004 (the or this "*First Amendment*"), is entered into by QUIKRETE HOLDINGS, INC., a Delaware corporation ("*Quikrete Holdings*"), THE QUIKRETE COMPANIES, INC., a Delaware corporation (formerly known as The Quikrete Companies, an Ohio corporation) ("*Quikrete Companies*") and QUIKRETE INTERNATIONAL, INC., a Delaware corporation ("*Quikrete International*"; and together with Quikrete Companies and Quikrete Holdings, individually, a "*Grantor*" and collectively, the "*Grantors*"), and WACHOVIA BANK, NATIONAL ASSOCIATION (formerly known as First Union National Bank), a national banking association, as Collateral Agent (the "*Collateral Agent*") under the hereinafter defined Intercreditor Agreement. Capitalized terms used herein shall have the respective meanings ascribed thereto in the hereinafter defined Intercreditor Agreement unless herein defined or the context shall otherwise require. Capitalized terms used herein and not defined herein or in the Intercreditor Agreement shall have the meanings assigned thereto in the Trademark Security Agreement (defined below).

**RECITALS:**

A. The Grantors and Wachovia Bank, National Association (formerly known as First Union National Bank), as lender (the "*Lender*") have previously entered into that certain Amended and Restated Loan Agreement, dated as of May 28, 2004 (as further amended, supplemented or otherwise modified from time to time, the "*Loan Agreement*").

B. The Grantors have entered into that certain Amended and Restated Note Agreement, dated as of May 28, 2004 (the "*1998 Note Agreement*"), between the Grantors and the Noteholders listed in Schedule 1 thereto (together with their respective successors and assigns, collectively, the "*1998 Noteholders*") pursuant to which the Existing 1998 Note Agreement and the Existing 1998 Senior Notes were amended and restated in their entirety (the Existing 1998 Senior Notes as so amended and restated are herein collectively referred to as the "*1998 Senior Notes*").

C. The Grantors have entered into that certain Amended and Restated Note Agreement, dated as of May 28, 2004 (the "*2000 Note Agreement*"), between the Grantors and the Noteholders listed in Schedule 1 thereto (together with their respective successors and assigns, collectively, the "*2000 Noteholders*") pursuant to which the Existing 2000 Note Agreement and the Existing 2000 Senior Notes were amended and restated in their entirety (the Existing 2000 Senior Notes as so amended and restated are herein collectively referred to as the "*2000 Senior Notes*").

D. The Grantors have entered into that certain Amended and Restated Note Agreement, dated as of May 28, 2004 (the "*2002 Note Agreement*"; and together with the 1998 Note Agreement and the 2000 Note Agreement, collectively, the "*Original Note Agreements*"), between the Grantors and the Noteholders listed on Schedule 1 thereto (together with their respective successors and assigns, collectively, the "*2002 Noteholders*"; and together with the 1998 Noteholders and the 2000 Noteholders, collectively, the "*Original Noteholders*") pursuant

to which the Existing 2002 Note Agreement and the Existing 2002 Senior Notes were amended and restated in their entirety (the Existing 2002 Senior Notes as so amended and restated are herein collectively referred to as the "*2002 Senior Notes*"; and together with the 1998 Senior Notes and the 2000 Senior Notes, collectively, the "*Original Senior Notes*"). The 1998 Noteholders, the 2000 Noteholders, the 2002 Noteholders and the Lender are hereinafter collectively referred to as the "*Original Secured Parties*".

E. The Grantors and the Collateral Agent have entered into that certain Amended and Restated Trademark Security Agreement, dated as of May 28, 2004 (the "*Trademark Security Agreement*"), pursuant to which the Grantors secured their respective obligations to pay all obligations arising pursuant to the Loan Agreement, the 1998 Note Agreement, the 2000 Note Agreement, the 2002 Note Agreement, the 1998 Senior Notes, the 2000 Senior Notes and the 2002 Senior Notes.

F. The Original Secured Parties and the Collateral Agent have heretofore entered into that certain Amended and Restated Collateral Agency and Intercreditor Agreement, dated as of May 28, 2004 (the "*Intercreditor Agreement*"), pursuant to which the Original Secured Parties appointed Wachovia Bank, National Association (formerly known as First Union National Bank) as the Collateral Agent. The Intercreditor Agreement otherwise sets forth the relative rights, priorities and obligations of the Original Secured Parties and the Collateral Agent with respect to the Collateral referred to therein.

G. The Grantors now propose to enter into that certain Note Agreement, dated as of December 1, 2004 (the "*2004 Note Agreement*") between the Grantors and the Noteholders listed on Schedule 1 thereto (collectively, the "*2004 Noteholders*") pursuant to which the 2004 Noteholders shall purchase the Grantors' 6.14% Senior Secured Notes due December 1, 2014 in the aggregate principal amount of \$60,000,000 (the "*2004 Senior Notes*").

H. The 2004 Senior Notes are to rank *pari passu* with the obligations of the Grantors under the Loan Agreement, the Original Note Agreements, the Original Senior Notes and each of the other existing Benefited Obligations and are to be secured ratably with the Loan Agreement, the Original Note Agreements, the Original Senior Notes and each of the other existing Benefited Obligations by the Trademark Security Agreement and each of the other Security Documents.

I. The Grantors and the Collateral Agent now desire to amend the Trademark Security Agreement in order to explicitly reflect the foregoing.

NOW, THEREFORE, the Grantors and the Collateral Agent, in consideration of good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, do hereby agree as follows:

#### SECTION 1. AMENDMENTS.

*Section 1.1.* The third WHEREAS clause of the Trademark Security shall be and is hereby amended and restated in its entirety to read as follows:

"WHEREAS, Quikrete Companies previously entered into that certain Note Agreement, dated as of September 12, 2002 (the "*Existing 2002 Note Agreement*"; and together with the Existing 1998 Note Agreement and the Existing 2000 Note Agreement, collectively, the "*Existing Note Agreements*"), between Quikrete Companies and the Noteholders listed in Schedule 1 thereto (the "*2002 Noteholders*") under and pursuant to which Quikrete Companies issued its 7.02% Senior Secured Notes due September 12, 2012 in the aggregate principal amount of \$60,000,000 (the "*Existing 2002 Senior Notes*"; and together with the Existing 1998 Senior Notes and the Existing 2000 Senior Notes, collectively, the "*Existing Senior Notes*")."

*Section 1.2.* The ninth WHEREAS clause of the Trademark Security Agreement shall be and is hereby amended and restated in its entirety to read as follows:

"WHEREAS, the Grantors have entered into that certain Amended and Restated Note Agreement dated as of the date hereof (as the same may be further amended, supplemented or otherwise modified from time to time, the "*2002 Note Agreement*") between the Grantors and the Noteholders listed on Schedule 1 thereto under and pursuant to which the Existing 2002 Note Agreement and the Existing 2002 Senior Notes will be amended and restated in their entirety (the Existing 2002 Senior Notes as so amended and restated are herein collectively referred to as the "*2002 Senior Notes*")."

*Section 1.3.* The WHEREAS clauses of the Trademark Security Agreement shall be and are hereby amended by inserting the following paragraph after the ninth WHEREAS clause of said Trademark Security Agreement:

"WHEREAS, the Grantors have entered into that certain Note Agreement, dated as of December 1, 2004 (as the same may be amended, supplemented or otherwise modified from time to time, the "*2004 Note Agreement*"; and together with the 1998 Note Agreement, the 2000 Note Agreement and the 2002 Note Agreement, individually, a "*Note Agreement*" and collectively, the "*Note Agreements*"), between the Grantors and the Noteholders listed in Schedule 1 thereto (collectively, the "*2004 Noteholders*"; and together with the 1998 Noteholders, the 2000 Noteholders and the 2002 Noteholders, collectively, the "*Noteholders*") pursuant to which the 2004 Noteholders purchased the Grantors' 6.14% Senior Secured Notes, due December 1, 2014, in the aggregate principal amount of \$60,000,000 (the "*2004 Senior Notes*"; and together with the 1998 Senior Notes, the 2000 Senior Notes and the 2002 Senior Notes, collectively, the "*Senior Notes*")."

*Section 1.4.* The tenth WHEREAS clause of the Trademark Security shall be and is hereby amended and restated in its entirety to read as follows:

“WHEREAS, the Grantors desire to secure their respective obligations to pay, duly and punctually, all obligations owing to the Noteholders and the Lender (together with their respective successors and assigns, collectively, the “*Secured Parties*”) pursuant to the Loan Agreement, the Note Agreements and the Senior Notes.”

## SECTION 2. MISCELLANEOUS.

*Section 2.1.* This First Amendment shall become effective and binding upon the Grantors and the Collateral Agent on the date hereof upon the acceptance hereof by the Grantors and the Collateral Agent in the space below.

*Section 2.2.* Except as modified and expressly amended by this First Amendment, the Trademark Security Agreement is in all respects ratified, confirmed and approved and all of the terms, provisions and conditions thereof shall be and remain in full force and effect.

*Section 2.3.* Any and all notices, requests, certificates and other instruments executed and delivered after the execution and delivery of this First Amendment may refer to the Trademark Security Agreement without making specific reference to this First Amendment but nevertheless all such references shall include this First Amendment unless the context otherwise requires.

*Section 2.4.* This First Amendment shall be governed by and construed in accordance with the laws of the State of Georgia.

*Section 2.5.* This First Amendment may be executed and delivered in any number of counterparts, each of such counterparts constituting an original, but all together only one First Amendment.



**AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT**

THIS AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT (this "*Trademark Security Agreement*") is made and entered into as of the 28th day of May, 2004, by THE QUIKRETE COMPANIES, INC. (formerly known as The Quikrete Companies, as Ohio corporation), a Delaware corporation ("*Quikrete Companies*"), QUIKRETE INTERNATIONAL, INC., a Delaware corporation ("*Quikrete International*") and QUIKRETE HOLDINGS, INC. ("*Quikrete Holdings*"; and together with Quikrete Companies and Quikrete International, collectively, the "*Grantors*"), in favor of WACHOVIA BANK, NATIONAL ASSOCIATION (formerly Known as First Union National Bank), a national banking association, in its capacity as Collateral Agent (the "*Collateral Agent*"), for the ratable benefit of Wachovia Bank, National Association, as a lender (the "*Lender*") and the Noteholders (as such term is defined below) (the Lender and Noteholders shall hereinafter be referred to collectively as the "*Secured Parties*").

**WITNESSETH:**

WHEREAS, Quikrete Companies previously entered into that certain Note Agreement dated as of January 1, 1998 (the "*Existing 1998 Note Agreement*") between Quikrete Companies and the Noteholders listed on Schedule 1 thereto (the "*1998 Noteholders*") under and pursuant to which Quikrete Companies issued its 8.13% Senior Secured Notes due January 15, 2008 in the aggregate principal amount of \$25,000,000 (the "*Existing 1998 Senior Notes*").

WHEREAS, Quikrete Companies previously entered into that certain Note Agreement dated as of May 1, 2000 (the "*Existing 2000 Note Agreement*") between Quikrete Companies and the Noteholders listed on Schedule 1 thereto (the "*2000 Noteholders*") under and pursuant to which Quikrete Companies issued its 9.96% Senior Secured Notes due May 30, 2010 in the aggregate principal amount of \$15,000,000 (the "*Existing 2000 Senior Notes*").

WHEREAS, Quikrete Companies previously entered into that certain Note Agreement, dated as of September 12, 2002 (the "*Existing 2002 Note Agreement*"; and together with the Existing 1998 Note Agreement and the Existing 2000 Note Agreement, collectively, the "*Existing Note Agreements*"), between Quikrete Companies and the Noteholders listed in Schedule 1 thereto (the "*2002 Noteholders*"; and together with the 1998 Noteholders and the 2000 Noteholders, collectively, the "*Noteholders*") under and pursuant to which Quikrete Companies issued its 7.02% Senior Secured Notes due September 12, 2012 in the aggregate principal amount of \$60,000,000 (the "*Existing 2002 Senior Notes*"; and together with the Existing 1998 Senior Notes and the Existing 2000 Senior Notes, collectively, the "*Existing Senior Notes*").

WHEREAS, Quikrete Companies also previously entered into that certain Loan Agreement, dated as of January 14, 1998 (the "*Existing Loan Agreement*") between Quikrete Companies and Lender (as successor-in-interest to First Union National Bank).

WHEREAS, in order to secure the obligations of Quikrete Companies under the Existing Loan Agreement, the Existing Note Agreements and the Existing Senior Notes, Quikrete Companies and Lender, in its capacity as collateral agent and lender, entered into a Trademark Security Agreement dated as of January 14, 1998 (the "*Existing Trademark Security Agreement*") pursuant to which Quikrete Companies granted to Lender, in its capacity as collateral agent, a lien on, and security interest in, the Trademark Collateral (as such term is defined in the Existing Trademark Security Agreement).

WHEREAS, the Grantors and the Noteholders now desire to amend and restate the Existing Note Agreements and the Existing Notes in their entirety for the purposes of adding Quikrete International and Quikrete Holdings as joint and several obligors in respect of the Existing Note Agreements and the Existing Senior Notes.

WHEREAS, in furtherance of the foregoing on the date hereof the Grantors are entering into that certain Amended and Restated Note Agreement dated as of the date hereof (as the same may be further amended, modified or supplemented from time to time, the "*1998 Note Agreement*") between the Grantors and the Noteholders listed on Schedule 1 thereto under and pursuant to which, among other things, the Existing 1998 Note Agreement and the Existing 1998 Senior Notes will be amended and restated in their entirety (the Existing 1998 Senior Notes as so amended and restated are herein collectively referred to as the "*1998 Senior Notes*").

WHEREAS, on the date hereof the Grantors are also entering into that certain Amended and Restated Note Agreement dated as of the date hereof (as the same may be further amended, modified or supplemented from time to time, the "*2000 Note Agreement*") between the Grantors and the Noteholders listed on Schedule 1 thereto under and pursuant to which the Existing 2000 Note Agreement and the Existing 2000 Senior Notes will be amended and restated in their entirety (the Existing 2000 Senior Notes as so amended and restated are herein collectively referred to as the "*2000 Senior Notes*").

WHEREAS, on the date hereof the Grantors are also entering into that certain Amended and Restated Note Agreement dated as of the date hereof (as the same may be further amended, supplemented or otherwise modified from time to time, the "*2002 Note Agreement*"; and together with the 1998 Note Agreement and the 2000 Note Agreement, collectively, the "*Note Agreements*") between the Grantors and the Noteholders listed in Schedule 1 thereto under and pursuant to which the Existing 2002 Note Agreement and the Existing 2002 Senior Notes will be amended and restated in their entirety (the Existing 2002 Senior Notes as so amended and restated are herein collectively referred to as the "*2002 Senior Notes*"; and together with the 1998 Senior Notes and the 2000 Senior Notes, collectively, the "*Senior Notes*").

WHEREAS, the Grantors desire to secure their respective obligations to pay, duly and punctually, all obligations owing to the Secured Parties pursuant to the Loan Agreement, the Note Agreements and the Senior Notes.

WHEREAS, the Secured Parties have entered into that certain Amended and Restated Collateral Agency and Intercreditor Agreement, dated as of the date hereof (as the same may be amended, modified or supplemented from time to time, the "*Intercreditor Agreement*") pursuant

to which the Secured Parties have appointed Wachovia Bank National Association as Collateral Agent and have otherwise set forth their understanding with respect to the sharing of collateral and certain other matters.

WHEREAS, as a condition precedent to the respective obligations of the Secured Parties under the Loan Agreement, the Note Agreements and the Senior Notes, and in furtherance of the Intercreditor Agreement, the Grantors have been required by the Secured Parties, among other things, to amend and restate the Existing Trademark Security Agreement, as more fully set forth herein, for the purposes of (i) adding Quikrete International and Quikrete Holdings as grantors to secure the obligations of the Grantors under the Loan Agreement, the Note Agreements and the Senior Notes and (ii) confirming and restating the grant by Quikrete Companies to the Collateral Agent, for the equal and ratable benefit of the Secured Parties, of a first-priority security interest in and to the Trademark Collateral (as defined in the Existing Trademark Security Agreement).

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantors hereby agree in favor of the Collateral Agent, for the benefit of itself and the ratable benefit of the Secured Parties, as follows:

1. *Defined Terms.* All capitalized terms used but not otherwise defined herein have the meanings given to them in that certain Amended and Restated Security Agreement, dated as of May 28th, 2004, by the Grantors in favor of the Collateral Agent for the ratable benefit of the Secured Parties.

2. *Confirmation and Restatement of Existing Lien; Grant of Security Interest in Trademark Collateral.* (a) Each Grantor hereby confirms that the lien on and the security interest in the Trademark Collateral (as defined in the Existing Trademark Security Agreement) shall remain in full force and effect and such security interest is perfected in all respects from the date of creation of such security interest thereunder and perfection thereof.

(b) Each Grantor hereby grants to the Collateral Agent, for the ratable benefit of the Secured Parties, a continuing first priority security interest in all of such Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "*Trademark Collateral*"):

(i) all of its Trademarks and Trademark Licenses to which it is a party including those referred to on Schedule I hereto;

(ii) all reissues, continuations or extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and

(iv) all products and proceeds of the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or

(ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

3. *Security Agreement.* The security interests granted pursuant to this Trademark Security Agreement are granted in conjunction with the security interests granted to Collateral Agent, for the ratable benefit of the Secured Parties, pursuant to the Security Agreement. 

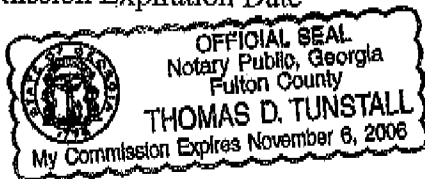

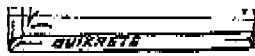
