

TRADEMARK USE AGREEMENT

Applicant Los Angeles County Metropolitan Transportation Authority ("LACMTA"), owner of the pending trademark application for EZ TRANSIT PASS, Serial No. 78/324860, hereby agrees to limit its use of the mark in this application (and any resulting registration) to the forms listed below. This is in furtherance of discussions held between LACMTA and the E-Z Pass Interagency Group which includes the Port Authority of New York and New Jersey.

1. **IN SERIATIM.** The LACMTA will limit the use of its EZ TRANSIT PASS mark *in seriatim* (in for instance, in text and other copy) to the specific form "EZ transit pass" (without regard to size or font). However, when used in a context such as a headline, table of contents, or similar instances where the majority of the surrounding text is in initial capitalization, the LACMTA may also use the specific form "EZ Transit Pass" (without regard to size or font). This exception is necessary to allow the LACMTA to clearly reference and differentiate its EZ TRANSIT PASS services within the particular material and/or to conform to the appearance or style of the surrounding text.
2. **STYLIZED.** The LACMTA will use the mark EZ TRANSIT PASS as a logo in the form of the letters "EZ" stacked over the words "TRANSIT PASS" (without regard to size, capitalization, font or other stylization).
