and the second assignee Stichting DEE, a corporation organized under the laws of the Netherlands with its principal place of business at Hoofdstraat 14, 3114 GG Schiedam, the Netherlands (the first and second assignee known collectively as "Assignees").

The effective date of this assignment is 21 November 2003.

Whereas, Assignor owns the following trademarks for the United States which are registered with the U.S. Patent and Trademark office.

(1) "Bottle Configuration" bearing U.S. Trademark Registration No. 2,217,998;

(2) "KETEL ONE and Design" bearing U.S. Trademark Registration No. 1,957,081;

(3) "KETEL ONE CITROEN and Design" U.S. Trademark Registration No. 2,037,782;

(4) and "NOLET" bearing U.S. Trademark Registration No. 2,388,085 (known collectively as "the Trademarks").

WHEREAS, Assignees are desirous of obtaining the Trademarks as joint owners and acquiring the entire right, title and interest thereto as joint owners, including the corresponding U.S. registrations, all associated common law rights, and the goodwill of the business symbolized thereby.





Assignor hereby sells, assigns, conveys and transfers jointly unto Assignees all right, title and interest in, to and under the Trademarks together with (a) all associated common law rights, (b) the goodwill of the business symbolized thereby, and (c) all rights and privileges granted and secured thereby, including, without limitation, the right to sue and recover for any past or continuing infringement of the Trademark, as well as the right to seek any and all remedies available at law or in equity;
2. Assignor agrees that it will make no further use of the Trademarks;
3. all said right, title and interest shall be held and enjoyed jointly by Assignees, for their own use and benefit and for the use and benefit of their successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made; the first assignee shall own 99/100 of all said right, title and interest; and the second assignee shall own the remaining 1/100 of all said right, title and interest.

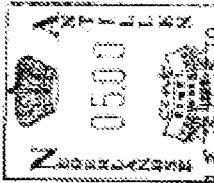
