THIS DEED dated the 28<sup>th</sup> day of September 2004

**BETWEEN** ZENIA HOUSE A/S , (Danish Central Business Register No.10 07 42 23) (Assignor)

**AND** TENON LIMITED, a New Zealand company of Auckland (Assignee)

## **BACKGROUND**

- A. The Assignor is the proprietor of the trade mark applications/registrations specified in Schedule A (collectively, the "Trade Marks").
- B. The Assignor has agreed to assign its rights in the Trade Marks to the Assignee for the consideration stated in this deed.

## **THE PARTIES AGREE:**

### **1. INTERPRETATION**

In this deed unless the context indicates otherwise:

"Effective Date" means 28 September 2004; and

### **2. ASSIGNMENT**

For the sum of \$1.00 and such further consideration as has been separately agreed between the parties (receipt and sufficiency of which is hereby acknowledged by the Assignor), the Assignor as legal owner hereby assigns to the Assignee from the Effective Date, all of its legal rights, title and interest worldwide (including legal ownership, and rights or licences to use) to and in the Trade Marks together with the goodwill held and associated with the business in relation to the Trade Marks.

### **3. FURTHER ASSURANCES**


The Assignor warrants that it is authorised to assign the Trade Marks and agrees to do all things and execute all documents reasonably required by the Assignee to perfect the assignment of the Trade Marks and other matters recorded in this deed and the Assignee's ownership of the Trade Marks, including anything required to register the Trade Marks in any trade mark registry or anything to assist the Assignee's successors to do so.

4. GOVERNING LAW

This deed shall be governed by the law of Denmark. The parties submit to the non-exclusive jurisdiction of the courts of Denmark.




