CONFIRMATORY ASSIGNMENT

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, Assignor acknowledges and confirms that Assignor has as of September 27, 1996, assigned, conveyed, and transferred unto Assignee the entire right, title, and interest in and to the Trademarks and the goodwill of the business symbolized by the Trademarks, the registrations thereof, and all common law rights, including the right to sue for damages and other remedies in respect of any infringement of the Trademarks which may have occurred before the date of this Confirmatory

Assignment. This Confirmatory Assignment is to have the same legal force and effect as if executed on September 27, 1996.
