TERMINATION OF SECURITY INTEREST


WHEREAS, Jerry's Famous Deli, Inc. ("JRI") with principal offices at 12711 Ventura Boulevard, Suite 400, Studio City, California, granted a Security Interest dated August 13, 2003 to Wolfie's Restaurant, Inc. ("WRI") with principal offices at 11900 Biscayne Boulevard, Suite 806, North Miami Beach, Florida, in (1) all of JRI's rights, title and interest in and to the trademarks "WOLFIE'S" and "WOLFIE'S & Design" for restaurant and delicatessen services (the "Marks") and all corresponding registrations and applications thereof, including but not limited to Florida Registration No. T03623, Serial No. 75/306,624, and Serial No. 75/626,876 goodwill of the business symbolized by the Marks, and (3) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same;

WHEREAS, said Security Interest was entered into to secure performance and payment of all the obligations of JRI pursuant to the Mediated Settlement Agreement ("MSA") dated September 24, 2002;

WHEREAS, JRI, has rendered all such performance and payment pursuant to the MSA;

NOW THEREFORE, WRI hereby terminates the effectiveness of said Security Interest as of the date last written below. JRI may publicly record this document with the U.S. Patent and Trademark Office and other bodies.
