FULL SATISFACTION OF MORTGAGE

WHEREAS, Trinity Springs, Ltd. (the "Company") and Pascal N. Levensohn, Andrew and Michele Hixon 2001 Trust, the Raisin Fund, LLC, Meisenbach Capital, Willey Weber, Richard H. Driehaus, and EFG Partners Fund, LP (collectively, the "Purchasers") entered into that certain Note Purchase Agreement dated August 7, 2002, as amended (the "Purchase Agreement"). Capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Purchase Agreement; and

WHEREAS, pursuant to the terms and conditions of the Purchase Agreement, certain security interests were granted to the Purchasers including: (i) UCC-1 Financing Statement filed on August 6, 2002 as Instrument No. B-2002-0929035-3 with the Secretary of State of the State of Idaho; (ii) Intellectual Property Security Agreement, dated as of August 7, 2002, filed on August 15, 2002 with the U.S. Patent and Trademark Office (the "Intellectual Property Security Agreement"); (iii) Mortgage, dated August 8, 2002 and recorded August 19, 2002 as Instrument no. 338784 in the real property records of Elmore County, Idaho; and (iv) Deposit Account Control Agreement, dated as of August 8, 2002 with Mountain West Bank (collectively, the "Security Interests"); and

WHEREAS, Levensohn Capital Advisors LLC was originally designated as the agent for the Purchasers (the "Designated Purchaser"), but was replaced by John Kanellitsas; and

WHEREAS, pursuant to a series of transactions contemplated by the Restated Rock Commitment, executed July 17, 2002 and restated on August 26, 2003, as amended (the "Rock Commitment"), Mercer Management, Inc. became the successor in interest to all the Purchasers' interests under the Purchase Agreement, including the Security Interests;

WHEREAS, pursuant to the Rock Commitment, the underlying debt and obligations secured by the Security Interests automatically converted into Series A Preferred Stock in the Company on March 31, 2004, thereby satisfying the underlying debt and obligations of the Purchase Agreement;

NOW THEREFORE, the undersigned hereby certify and declare that for good and valuable consideration, the receipt of which is hereby acknowledged, the debt, lien and charge created by and under the Purchase Agreement and the Security Interest documents was assigned to Mercer Management, Inc., and have been fully and completely satisfied, terminated and discharged, and the underlying debt or obligation secured by the Security Interests has been paid in full.

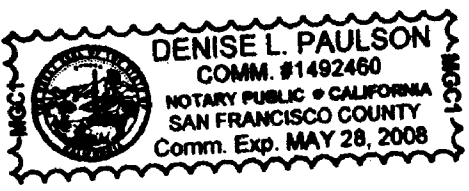

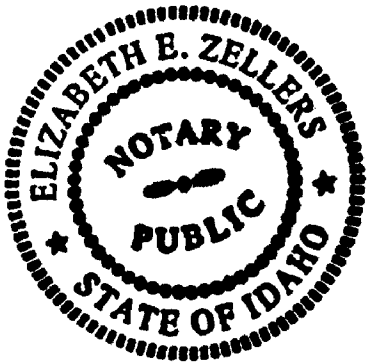
