**TRADEMARK ASSIGNMENT**

**WHEREAS**, Tachikara Co., Ltd, a corporation organized and existing under the laws of Japan ("Assignor"), has adopted, owns and is using the United States trademarks for "TACHIKARA," the United States trademark for "LOOSE BLADDER CONSTRUCTION," the United States trademark for "SINGLE UNIT CONSTRUCTION," and the Canadian trademarks for "TACHIKARA" ("the Marks") in connection with the goods and services listed on Exhibit "A" attached hereto and incorporated herein by reference; and

**WHEREAS**, Under that certain Trademark Assignment Agreement, dated July 3, 1998, Assignor assigned partial title in the US Trademarks to Yuan Chi Overseas Ltd. & Oriental Spirit Ltd. ("Yuan Chi") and Tachikara U.S.A., Inc.
