ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK (this "Agreement") is made as of January 22, 2005, between DAN RIVER INC., a Georgia corporation ("Assignor"), and PORTERDALE ACQUISITION, LLC, a Delaware limited liability company ("Assignee").

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of December 10, 2004, by and among Assignor, Assignee, and Industrial Specialty Fabrics, Inc., as guarantor (the "Asset Purchase Agreement"), Assignor agreed to sell, assign and transfer to Assignee, and Assignee agreed to purchase and acquire from Assignor, all transferable Intellectual Property Rights (as defined in the Asset Purchase Agreement), including, without limitation, the trademark set forth on Schedule A attached hereto, all registrations or pending applications therefor, all common law rights therein, and all goodwill associated therewith (collectively, the "Intellectual Property");

NOW, THEREFORE, in consideration of the mutual covenants set forth in the Asset Purchase Agreement, and such further mutual covenants herein contained, the parties hereto agree as follows:

1. Transfer of Intellectual Property. Assignor does hereby sell, convey, transfer, assign and deliver unto Assignee, its successors and assigns, the entire right, title and interest in, to and under the Intellectual Property, together with the goodwill of the business symbolized by the Intellectual Property and all rights to sue and recover for any past infringements of any of the Intellectual Property, the same to be held and enjoyed by said Assignee for its own use and for the use of its successors and assigns.

2. Confirmatory Instruments. Assignor and Assignee hereby mutually covenant and agree that they will, upon the request of either to the other, execute any and all further instruments, transfers, assignments, conveyances, assurances and filings confirmatory to the foregoing assignment of the Intellectual Property which may be reasonably required in order to accomplish the purposes and benefits of this Agreement.

3. Capitalized Terms. All capitalized terms not defined in this Agreement shall have the meanings assigned to them in the Asset Purchase Agreement.


4. Governing Law. This Agreement shall be construed in accordance with the laws of the State of Georgia, without regard to the principles of conflicts of law.


