DISCHARGE AND TERMINATION OF SECURITY INTEREST

This Discharge and Termination of Security Interest is effective as of this 14th day of February, 2005.

WHEREAS, HCI SYSTEMS, INC., a corporation formerly of 1662 Post Road, Unit 3-B, Wells, Maine 04090, granted a security interest in and lien on two trademark registrations bearing the Registration Numbers 2218695 and 2268351 (the "Security Interest") to IMPERIAL BANK, a California chartered bank having a mailing address of 226 Airport Parkway, San Jose, California 95110 ("Imperial Bank"); and

WHEREAS, the Security Interest was filed with the Assignments Division of the United States Patent and Trademark Office, in Reel 1861, Frame 339; and

WHEREAS, Imperial Bank was acquired by COMERICA BANK-CALIFORNIA, a banking institution having a mailing address of c/o Technology & Life Sciences Division, Five Palo Alto Square, Suite 800, 3000 El Camino Real, Palo Alto, California 94306 ("CoMerica Bank-California"); and



DIAMOND, individually and as agent for the New Lenders, so-called, having a mailing address of 75 Strathearn Road, Toronto, Ontario, Canada M6C 1R5 (collectively, "Diamond") by virtue of a certain Loan Purchase and Sale Agreement by and between the parties dated November 22, 2002; and

WHEREAS, Diamond, as the holder of the Security Interest, wishes to discharge, terminate and release the Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Diamond states as follows:

Diamond, as the holder of a certain Security Interest given by HCI Systems, Inc. dated February 17, 1999 and recorded in the Assignments division of the U.S. Patent and Trademark Office on February 25, 1999 in Reel 1861, Frame 339, acknowledges satisfaction of the same and hereby discharges, terminates and releases said Security Interest.


