TRADEMARK ASSIGNMENT

NOW THEREFORE, in consideration of the mutual covenants contained herein and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

Teddi hereby assigns unto Anderson its entire right, title and interest in and to the United States Trademark Registration set forth and particularly listed in Schedule A (the "Subject Mark"), together with that portion of the business associated with, and the goodwill of the business symbolized by, the Subject Mark and registration thereof.

Upon Anderson's request, Teddi will execute and deliver all further instruments of conveyance, assignment and transfer and take all other action that Anderson reasonably may require to more effectively convey and transfer to Anderson the Subject Mark, including any and all documents which may be required by the United States Trademark Office to perfect the conveyance, assignment and transfer of said Subject Mark to Anderson.

This Assignment shall inure to the benefit of Anderson and its successors and assigns. If any provision hereof shall be finally determined to be invalid or unenforceable, such provision shall be deemed to be stricken from this Assignment and the remainder hereof shall remain in full force and effect.
