**NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

Reference is made to (i) that certain Security Agreement dated as of March 31, 1998, recorded at the United States Patent and Trademark Office at Reel 001709 and Frame 0390 on April 1, 1998 and (ii) that certain Security Agreement dated as of January 15, 1999, recorded at the United States Patent and Trademark Office at Reel 001844 and Frame 0250 on January 22, 1999 (collectively, the "Security Agreements"), each made by Z-Spanish Radio Network, Inc.
