**REVISED ASSIGNMENT OF TRADEMARK AND
REGISTRATIONS THEREOF**

This revised assignment is made by and between Aaron's Automotive Products, Inc., a corporation existing under the laws of the State of Delaware, having a principal place of business at 2600 North Westgagge Avenue, Springfield, Missouri 65803 ("Aaron's Automotive") and ATC Aftermarket, Inc., a corporation existing under the laws of the State of Delaware; subsequently thereto merging into ATAT Remanufacturing, Inc., a corporation existing under the laws of the State of Delaware; the name of the surviving company of said merger being changed to **PROformance Powertrain Products, Inc.**, a corporation existing under the laws of the State of Delaware, having its principal place of business at 2720 North Airport Commerce Avenue, Springfield, Missouri 65803 (hereinafter "Assignee"). The prior assignment executed on March 23, 2004 misspelled the name of Assignee as PROformance Powertrain Productions, Inc., when in fact, the correct spelling of Assignee's name is PROformance Powertrain Products, Inc.
