## ASSIGNMENT OF TRADEMARK

Assignor hereby sells, assigns, transfers and sets over to Assignee all rights, title, and interest in and to the Mark, together with all of the goodwill of the businesses and business concepts symbolized thereby, as well as the registration and other rights, including common law rights, Assignor may have throughout the world with respect to such Mark for the consideration of \$4,000.00.

2. Assignor hereby assigns, sells, transfers and sets over unto Assignee all claims for damages for reason of past infringement of the Mark, as well as the right to sue for and collect the same for its own use and enjoyment.

3. Assignor further authorizes the Commissioner of Patents and Trademarks of the United States and any official of any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Mark and title thereto as the property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this instrument.

4. Assignee hereby waives and releases Assignor from any claims, damages or causes of action associated with or arising out of Assignor's ownership or use of the Mark, or Assignor's transfer of the Mark to Assignee.





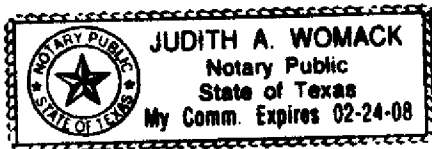
