## ASSIGNMENT OF TRADEMARKS AND TRADEMARK APPLICATIONS

WHEREAS, Celltech Pharmaceuticals, Inc., a Delaware corporation ("**Celltech**") or its Affiliates (as defined herein), is the owner of all right, title and interest in the United States and Puerto Rico (the "**Territory**") in the trademarks used by Celltech or any of its Affiliates set forth on Schedule A attached hereto, and is the owner of the Registrations of, or the Applications to register, such trademarks in the Territory (including registrations and applications in any state or at the United States Patent and Trademark Office) identified on such Schedule A; and

WHEREAS, Carolina Pharmaceuticals, Inc. ("**Carolina**"), is desirous of acquiring the "Trademarks, Registrations and Applications" (as defined in Schedule A below); and

WHEREAS, Celltech and Carolina Pharmaceuticals, Inc. have entered into an Asset Purchase Agreement dated as of the date hereof, pursuant to which Celltech has agreed to sell, assign and transfer the Trademarks, Registrations and Applications pursuant to the terms thereof and hereof.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Celltech does hereby assign, sell and transfer unto Carolina all right, title and interest in and to the trademarks, registered or unregistered, or service marks used by Celltech or any of its Affiliates in the Territory and any Registrations (including renewals or extensions) or Applications to register such trademarks or service marks in the Territory including without limitation those set forth on Schedule A hereto (collectively the "**Trademarks, Registrations and Applications**"), together with all common law and statutory right, title and interest in and to the Trademarks, Registrations and Applications, all goodwill relating thereto in the Territory, and all rights of registration, maintenance, renewal and protection of the Trademarks, Registrations and Applications, including without limitation all rights of recovery and of legal action for past infringements and of opposition and/or cancellation proceedings for protection of the Trademarks, Registrations and Applications.

This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York (regardless of that jurisdiction's or of any other jurisdiction's choice of law principles that would lead to a contrary result). The parties unconditionally and irrevocably consent to the exclusive jurisdiction of the courts located in New York, New York and waive any objection with respect thereto, for the purpose of any action, suit or proceeding arising out of or relating to this Assignment or the transactions contemplated hereby.

As used in this Assignment the term "**Affiliate**" means any entity controlling, controlled by or under common control with Celltech, where "control" shall mean (a) the ownership of at least fifty percent (50%) of the equity or beneficial interest of such entity, or the right to elect or appoint a majority of the board of directors or other governing body of such

entity, or (b) the power to directly or indirectly direct or cause the direction of the management and policies of such entity by any means whatsoever.
