ASSIGNMENT OF TRADEMARK

WHEREAS, the parties desire to formalize and reaffirm said assignment and record same in the U.S. Patent and Trademark Office;



ASSIGNOR does also hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the TRADEMARK, the right to sue for and collect the same for its own use and enjoyment and the use and enjoyment of its successors, assigns and other legal representative; and

ASSIGNOR further agrees to execute such further documents as may be required to record ASSIGNEE as the owner of the TRADEMARK herein assigned.
