U.S. TRADEMARKS RELEASE OF SECURITY INTEREST

THIS RELEASE dated as of September 30, 2004, by WILMINGTON TRUST COMPANY, as Collateral Agent for the Secured Parties (as defined below). Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Domestic Security Agreement referred to below.

Reference is made to (a) the Indenture dated as of February 17, 2004 (as amended, supplemented or otherwise modified from time to time, the "Indenture"), among PLIANT CORPORATION, a Utah corporation (the "Issuer"), the Note Guarantors (as defined in the Indenture) and WILMINGTON TRUST COMPANY, as trustee, and (b) the Domestic Security Agreement dated as of February 17, 2004 (as amended, supplemented or otherwise modified from time to time, the "Domestic Security Agreement"), among the Grantors and WILMINGTON TRUST COMPANY, as collateral agent (the "Collateral Agent"), pursuant to which, among other things, Pliant Solutions Corporation, a Utah corporation and a Grantor under the Domestic Security Agreement ("Pliant Solutions"), granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the certain registered trademarks and pending trademark applications of Pliant Solutions set forth on Annex I hereto (the "Trademarks"), which security interest was recorded with the United States Patent & Trademark Office.

In connection with the sale of certain of the assets of Pliant Solutions, as permitted under Section 4.06 of the Indenture, Pliant Solutions has informed the Collateral Agent of its desire to obtain the release of all right, title and interest of the Secured Parties and each other grantee or beneficiary in and to the Trademarks under the Indenture and the Domestic Security Agreement.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all the Collateral Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks shall automatically terminate as provided by Section 10.03 of the Indenture and Section 8.14 of the Domestic Security Agreement. This Release shall not result in any release or termination of the security interest of the Collateral Agent in any of the registered trademarks or pending trademark applications of any of the other Grantors under the Indenture and the Domestic Security Agreement.
