NO PERSONAL LIABILITY OF THE JOINT ADMINISTRATIVE RECEIVERS

The parties hereby agree that the Joint Administrative Receivers are party to the Assignment only for the purposes of receiving the benefit conferred on them under the assignment and it is hereby expressly agreed and declared that no personal liability under or in connection with this Assignment shall fall on the Joint Administrative Receivers or their firm, partners, employees or agents whether such claim is formulated in contract and/or tort or by reference to any other remedy or right and in whatever jurisdiction or forum.

~~It is hereby expressly agreed and declared that the Joint Administrative Receivers~~ when acting in the name and on behalf of the Assignor shall incur no personal liability by reason of acting in that capacity nor shall any claim arise otherwise than against the Assignor.


