TERMINATION OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION OF TRADEMARK SECURITY AGREEMENT ("Termination") is granted by Citizens Bank of Massachusetts ("Lender"), a Massachusetts corporation to Hardigg Industries, Inc. ("Borrower"), a Massachusetts corporation.

WHEREAS, Lender is the owner and holder of a certain Trademark Security Agreement executed June 14, 2000, and recorded in the U.S. Patent & Trademark Office on March 9, 2001, at Reel 2259/Frame 0001 for the following U.S. Registered Trademarks:
