

**RELEASE OF SECURITY INTEREST**

This Release (this "Release") is made as of March 2, 2005 by CITICORP NORTH AMERICA, INC., a Delaware corporation as administrative agent ("CNAI") (as successor in interest of The Bank of Nova Scotia), for the benefit of CORRCHOICE LLC (successor by merger to CorrChoice, Inc.) (the "Company").


