**CERTIFICATE OF AMENDMENT
OF THE
ARTICLES OF ORGANIZATION
OF
MAVERICK LACROSSE LLC**

Under Section 211 of the Limited Liability Company Law of the State of New York

1. The name of the limited liability company is Maverick Lacrosse LLC (“Company”).
2. The date of the filing of the Articles of Organization of Maverick Lacrosse LLC with the New York Secretary of State is October 8, 2004.
3. The Articles of Organization as now in full force and effect are hereby amended as follows as authorized by Section 211 of the Limited Liability Company Law of the State of New York:

A. Paragraph FIRST of the Articles of Organization which sets out the name of the Company shall be deleted in its entirety and is hereby amended in its entirety to read as follows:

“FIRST: The name of the limited liability company (the “Company”) is Maverik Lacrosse LLC.”

B. A new Paragraph FOURTH to the Articles of Organization, which provides for the management of the Company by one or more managers, is hereby added to the Articles of Organization and shall read as follows:

“FOURTH: The Company shall be managed by one or more managers.”
