ARTICLES OF MERGER
of
LUCK STONE, LLC
LUCK SAND & GRAVEL, LLC
LEE TENNIS, LLC
and
LUCK EARTHSCAPES SUPPLY, LLC
with and into
LUCK STONE CORPORATION

1. Plan of Merger. Attached as the Appendix is the plan of merger ("Plan") by which each of Luck Stone, LLC, a Virginia limited liability company, Luck Sand & Gravel, LLC, a Virginia limited liability company, Lee Tennis, LLC, a Virginia limited liability company, and Luck Earthscapes Supply, LLC, a Virginia limited liability company (individually, a "Merged Company" and together, the "Merged Companies"), shall be merged into Luck Stone Corporation, a Virginia corporation (the "Surviving Corporation").
2. Adoption of the Plan. The Plan was adopted by unanimous written consent of the directors of the Surviving Corporation. The Plan does not require the approval of the shareholders of the Surviving Corporation because the articles of incorporation of the Surviving Corporation will not differ from its articles of incorporation before the merger; each shareholder of the Surviving Corporation whose shares were outstanding immediately before the effective date of the merger will hold the same number of shares of the Surviving Corporation, with identical designations, preferences, limitations and relative rights, immediately after the merger; and the number of voting and participating shares of the Surviving Corporation after the merger will be identical to the number of voting and participating shares of the Corporation immediately before the merger. The Plan was adopted by the sole member of each Merged Company in accordance with Virginia Code Section 13.1-1071.
3. Effective Time. The effective date of the certificate of merger issued by the Virginia State Corporation Commission, and the date on which the merger of the Merged Companies with and into the Surviving Corporation shall be effective, shall be October 31, 2001.
