The Commissioner of Patents and Trademarks is requested to issue the Certificate of Registration to said assignee, UNITED SUPERMARKETS, LTD.

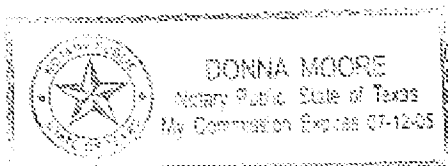
