McTurnan was an officer of Bredero Price, Inc., a Delaware corporation, on March 15, 1989, and was an officer of Bredero Price International, Inc. on June 1, 1995, when the above marks, with their certificates of registration and the good will of the business symbolized thereby, were acquired by Bredero Price Company, a Delaware corporation;

NOW, THEREFORE, for good and valuable consideration previously given, Bredero Price, Inc., a Delaware corporation, hereby assigns, nunc pro tunc, effective March 15, 1989, all right, title and interest in and to the marks Price logo and PRILO-K and their certificates of registration, together with the good will of the business associated therewith, to Bredero Price International, Inc., a Texas corporation; and

THEREUPON, for good and valuable consideration previously given, Bredero Price International, Inc., a Texas corporation, hereby assigns, nunc pro tunc, effective June 1, 1995, all right, title and interest in and to the marks Price logo, PRILO-K, HEVICOTE (stylized) and PRITEC, and their certificates of registration, together with the good will of the business associated therewith, to Bredero Price Company, a Delaware corporation;

WHEREBY, the entire right, title and interest in and to the trademarks Price logo, PRILO-K, HEVICOTE (stylized) and PRITEC and their respective registrations, together with the good will of the business associated therewith, is by this document conveyed by direct assignment (Reg. Nos. 609,803 and 1,002,428) or by mesne assignment (Reg. Nos. 1,069,963 and 1,132,870) to Bredero Price Company, a Delaware corporation.
