DEED OF ASSIGNMENT is made on

31 March 2004

BETWEEN

(1) DAWSON INTERNATIONAL HOLDINGS (UK) LIMITED (registered number SC054674) whose registered office is at Lochleven Mills, Kinross, KY13 8GL, United Kingdom (the "Assignor"); and

(2) UNITED CASHMERE BRANDS VEDJEGYHASZNOSITO KFT registered in Hungary whose registered office is at H-1036 Budapest, Becsi ut 52, Hungary (the "Assignee")

THE PARTIES AGREE as follows:

1 Definitions

1.1 In this Deed of Assignment:

"Design Registrations" means the design registrations listed in part C of the Schedule to this Deed of Assignment.

"Registered Trade Marks" means the registered trade marks registrations listed in part A of the Schedule to this Deed of Assignment.

"Sale Agreement" means the agreement dated today's date and made between, amongst others, the Assignor and the Assignee, under which the Assignor agreed to assign the Registered Trade Marks, Trade Mark Applications and Design Registrations to the Assignee.

"Trade Marks Applications" means the trade mark applications listed in part B of the Schedule to this Deed of Assignment.

2 Assignment

Pursuant to the Sale Agreement the Assignor hereby assigns to the Assignee absolutely:

2.1 all of its right title and interest in the:

2.1.1 Registered Trade Marks (in respect of all the goods or services for which the Registered Trade Marks are registered);

2.2 the goodwill attaching to the Registered Trade Marks, Trade Mark Applications, Design Registrations and any unregistered design rights.

3 Further Assurance

The Assignor shall on request by the Assignee in writing and at the Assignee's expense subject to clause 11.3 of the Sale Agreement do and execute or arrange for the doing and executing of, each necessary act, document and thing reasonably within its power to implement this Deed of Assignment.

4 Assistance with Applications

The Assignor shall on request by the Assignee in writing and at the Assignee's expense give such assistance as the Assignee may reasonably request to complete the registration of trade marks and design rights pursuant to the Trade Mark Applications.

5 Assistance with Proceedings

If in any proceedings, a claim is made, at any time, seeking the invalidation or revocation of a Registered Trade Mark or of a registration granted pursuant to a Trade Mark Application, or opposing the grant of a registration pursuant to a Trade Mark Application, the Assignor shall on request by the Assignee in writing give all reasonable assistance to the Assignee at the Assignee's expense in relation to those proceedings (including by participation in the proceedings). Similarly, if in any proceedings a claim is made, at any time, seeking the invalidation or revocation of a Design Registration, the Assignor shall on request by the Assignee in writing give all reasonable assistance to the Assignee at the Assignee's expense in relation to those proceedings (including by participation in the proceedings).

6 Governing Law

This Deed of Assignment is governed by English law.

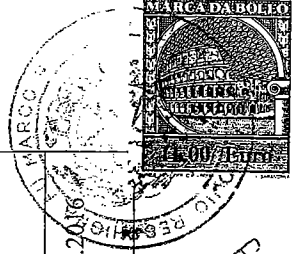

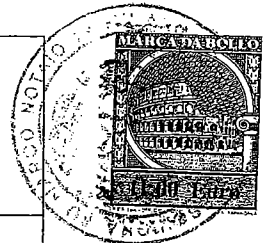

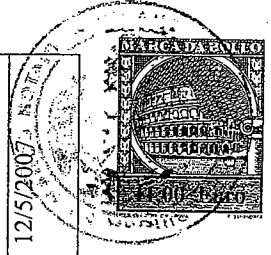
